Subject: Minutes of Meeting of CWC AIR and DD Engineers' Association held on 22nd June 2025

A meeting of the Central Working Committee (CWC) of the AIR and DD Engineers' Association (ADEA) was convened on 22nd June 2025, from 12:00 PM to 1:00 PM via Zoom Meeting. Following CWC members and executives attended the meeting:

Following decisions were taken by the body during the meeting:

1. The Vice President chaired the meeting. He welcomed all members and opened the discussion by addressing the long-pending issue of conducting ADEA elections for the term 2025–27. CWC decided to conduct the elections on priority.
2. The name of Shri P.P. Shukla, ADG, as the Returning Officer for the elections was unanimously accepted by the committee. Vice president informed that Sh. Shukla has already consented this proposal during an informal discussion. ADEA executives will issue a formal communication to Shri P P Shukla, IBES in this regard preferably in the coming week.
3. It was decided that the elections shall be held among the members of the association as on 1st of April 2025. The list of voters shall be compiled and communicated to the returning officer.
4. CWC decided that the matter of collection of annual subscription shall be taken up with IRLA. Efforts would be made to claim the money deducted by IRLA from ADEA members at the earliest.
5. Hon. Treasurer appraised about the dormancy of 2 of the 3 bank accounts of ADEA. It was learnt that one account with HDFC and other account in PNB have become dormant

due to the pending KYC updates. It was told to the body that despite repeated efforts these accounts couldn't be made active. CWC decided to close the account with HDFC after withdrawal of ADEA money and transfer it to its PNB account. Also decided to operationalise the PNB dormant account by updating its KYC with the Bank. Sh M Baiju Hon. Treasurer entrusted with this task.

6. The committee then discussed issues related to the ADEA Google Group. It was agreed that the group administrator would review and clean up the group, ensuring only ADEA members with valid and personal email addresses are retained, maintaining authenticity and privacy.
7. The status of the ADEA website was also reviewed. It was reported that the site was inactive due to pending subscription renewals. Shri K.K. Rao, the Publicity Secretary, was entrusted with the task of taking immediate steps to restore website functionality.
8. On the matter of "President's Pleasure" orders not being issued to some IBES officers promoted in the recent past, Shri Sanjeev Saxena, CWC Member and ADG(HR-PB) informed the committee that necessary action will be initiated by Prasar Bharati Administration to take up the matter with MIB.

The meeting ended with a formal vote of thanks to all present members.
