The recommendations made by the Sixth Central Pay Commission have been accepted by the Govt. of India vide Min. of Finance Resolution dated 29th August, 2008. These recommendations include Non Functional Upgradation to the officers of organized Group 'A' services (relevant page of 6th Pay Commission notification placed at Annexure-I) which States the following:

“Whenever any IAS officer of a particular batch is posted in the Centre to a particular grade carrying a specific grade pay in pay bands PB-3 or PB-4, grant of higher pay scale on non-functional basis to the officers belonging to batches of organized Group 'A' services that are senior by two years or more should be given by the Government.”

Guidelines for implementation of the above 6th CPC recommendation have been issued by DoPT, Min. of Personnel, Public Grievances and Pensions vide Order no. AB 14017/64/2008-Estt.(RR) dated 24.04.2009 (Annexure-2) and subsequent orders/clarifications in this regard have been issued on 21.05.09 and 25.09.09(Annexure-3 & 4). Further in response to few issues raised by some IB(E)S Officers DOPT has again clarified the definition of the batch vide their letter dated 11.12.09 (Annexure-5).

Accordingly officers belonging to IB(E)S service are to be considered for grant of Non Functional Up gradation in respective grade retrospectively as per Batch wise eligibility vide DOPT order dated 21.05.09. Batch wise list of the IB(E)S officers in STS and above grade (Annexure 6-29) who are to be considered for the above Upgradation has been prepared and enclosed along with their seniority lists (Annexure 30-35) showing their batch and date of joining as Group 'A' (JTS level) service.

Some of the Departments/Ministries have already initiated action in this regard and have issued orders for Non Functional up gradation in respect of their officers. Copies of orders issued by Ministry of Railways (Annexure-36), Planning Commission (Annexure-37) & Ministry of Urban Development (Annexure-38) are enclosed for kind reference.

In view of above, Ministry may kindly initiate necessary action for constituting screening committees for granting Non-functional Upgradation to the IB(E)S officers as applicable to organized Group 'A' services as per the acceptance of the recommendations of the sixth pay commission in respect of pay parity with IAS. This office has already started action for arranging CRs and other formalities required in respect of the officers whose name figured in the above mentioned lists for forwarding it to Ministry as and when required .
