Eligibility conditions for contesting / voting (Refer Clause 32 of the Constitution)

- (a) Life Members / those paid Up Members who have paid their subscriptions of at least two constitutive financial years ending 31st March of the election year and whose name figures in Voter List 2011-2012 will be eligible to contest and vote for the posts of the Office Bearers of the Association as notified.
- (b) For the posts of Regional Secretaries of each Zone, only the Life Members / Paid Up Members of respective Region, who are eligible in (a) above, and whose name figures in Voter List 2011-2012 will be eligible to vote and contest the elections.
- (c) Only those members who have served AIR / Doordarshan for at least two years or more on the date of notification of the elections and are still in service in AIR / Doordarshan and have at least two years of service left on the date of filing of nomination, will be eligible to contest in the election, subject to satisfying all other conditions.
- (d) Members who are retiring from service on or before 31st March of the election year are not eligible to participate in the elections.
- (e) A member will be allowed to file the nomination for one post of Office Bearer only.
- (f) Those contesting the elections, have to deposit Rs.200/- (Rupees Two Hundred Only) as Security Deposit, in cash or by bank draft, drawn in favour of AIR & Doordarshan Engineers Association, payable at Delhi, alongwith nomination form. The Security Deposit shall be forfeited for the candidates, for whom the total votes polled are less than ten percent (10%) of the total votes cast and found valid.
- (g) The Proposer & Seconder filing the nomination form for election are eligible to sign only for one Candidate, for one post. The Nomination proposed and / or seconded for two or more contestants by same proposer and / or seconder, will become invalid.

Further, contesting candidates may forward their resume not exceeding 150 words for posting on Association Web Site for the general information of all the members.

All the members are requested to extend all necessary help in the smooth conduct of election and provide wide publicity to all the nearby units for their active participation in electing the representatives.
